# 2025 Trash Collection, Watershed Protection Fee Assistance & Bay Fee Hardship Exemptions Deadline: June 1, 2025

There is a refuse collection charge assistance program, administered by the Department of Finance, to assist individuals who qualify under the program in payment of the refuse collection charge established under subtitle 20.904 of the Howard County Code.

### **Eligibility Requirements:**

- $\Box$  The applicant must own the residential property for which the County provides refuse collection services, OR
  - Owns a mobile home that is located in a mobile home park in the County, for which the County provides refuse collection service, if the individual submits evidence that he or she is paying the refuse collection charge to the park owner under subsection 16.511(d) of the County Code.
- ☐ The individual's income is 250 percent or less of the poverty level, as established by the U.S. Department of Health and Human Services and adjusted for family size.
- □ On July 1 of the year in which application is made, the individual:
  - o Resides in the property for which refuse collection services are provided; or
  - o In the case of a mobile homeowner, the individual resides in the mobile home.
